A regular meeting of the Hume Town Board, 20 North Genesee Street, Fillmore, New York; Allegany County took place on December 13, 2017 at the Wide Awake Club Library, 22 North Genesee Street, Fillmore, New York, at 7PM, in the Gerald McGlynn Community Room. Officials in attendance were: Supervisor Dennis Ricketts; Councilmembers Darlene Mason, Bruce Hinz, Christopher Austin and Daniel Miller; and Town Clerk Susan Bodnar.

#### MINUTES

Councilman Austin moved to accept the Minutes of the November 7, 2017 Board Meeting. Councilman Miller seconded the motion. 5 ayes. 0 noes.

Dog Control Officer Leslie Claggett discussed the option to do away with Purebred Licensing in the Town.

#### MUSEUM

Historian Rondus Miller talked about the second phase of the grant for the Museum. This phase is about adding an Accessible Chairlift to the entrance of the Museum. A motion was made by Supervisor Ricketts to pay the chairlift company \$25,000 for a down payment and pay the remaining balance when the installation was completed. Councilman Miller seconded. 5 ayes. 0 noes.

#### EXECUTIVE SESSION

Councilwoman Mason motioned to go into Executive Session for the need of an Attorney/Client Conference. Councilman Austin seconded. 5 ayes. 0 noes.
