

CR 4 OVER GENESEE RIVER BRIDGE REHABILITATION

This project proposes to rehabilitate the bridge that carries County Road 4 (E. Main St.) over the Genesee River in the Town of Hume. The purpose of this meeting is to provide information regarding the project objectives and alternatives being considered at a point in the project development where public input can be considered in alternative selection and final design.

Background:

The bridge that carries CR 4 over the Genesee River was built in 1980 and is a four-span steel multi-girder structure with a concrete deck founded on concrete abutments. The existing bridge is in overall good condition, however there are several elements that are starting to deteriorate and become deficient. Current deficiencies include spalling and cracking of the reinforced concrete deck and reinforced concrete approach slabs, failed bridge joints at both abutments, deterioration to bearings at abutments, non-standard bridge railing, and spalling and deterioration of the existing abutments. A gravel bar in the river has also built up over time around the bridge. This is pushing the water in the river to the east side of the river and is causing erosion to the eastern river bank immediately upstream of the bridge.

Project Objectives:

The objective of this project is to preserve and prolong the life of the existing bridge through cost effective rehabilitation strategies.

Alternatives Considered:

Three (3) alternatives were considered as a solution to the identified problems. They are: 1. Null Alternative; 2. Replacement; 3. Rehabilitation.

- The Null Alternative provides for only continued maintenance of the structure. This alternative implies that no major repairs or improvements would be made to the structure and that the existing conditions and deficiencies would remain. The costs associated with this alternative would include the increasing amount of time and money needed to maintain the structure and keep it open to traffic. This alternative will not satisfy the project objectives so it was removed from further consideration.
- The Replacement Alternative would involve replacing the existing bridge with a new bridge meeting current design standards. This alternative would satisfy the project objectives but has been determined to not be cost effective given the overall good condition of the existing bridge. Therefore it was removed from further consideration.
- 3. The Rehabilitation Alternative would involve rehabilitation of the existing abutments, replacement of the existing bearings at the abutments, cleaning and painting the ends of the existing steel beams, complete replacement of the existing bridge deck with a new concrete bridge deck, complete replacement of the concrete approach slabs, construction of new bridge and approach guide rail, cleaning and washing all bridge components, removal of built up gravel bar around the bridge, and installation of heavy rip rap along the eastern river bank to prevent future erosion. This alternative has been identified as the only prudent and feasible solution that meets the project objectives.

Project Parameters:

- Funded through the BridgeNY Program (95% Federal, 5% Local)
- One, alternating lane of traffic on the bridge during construction.
- No Right of Way easements or acquisitions are anticipated.
- No utility impacts are anticipated.
